PAYMENT OF MANAGER'S BASE FEES BY WAY OF ISSUE OF UNITS IN MAPLETREE INDUSTRIAL TRUST

6 February 2012 – Mapletree Industrial Trust Management Ltd., as manager (the "Manager") of Mapletree Industrial Trust ("MIT"), wishes to announce that 471,027 new units in MIT ("New Units") have been issued to the Manager on 6 February 2012 at \$1.0828 per unit.

In accordance with the Trust Deed, the Manager has elected to receive the payment of base fee¹ in New Units in respect of the Flatted Factories portfolio acquired from JTC Corporation². The New Units have been issued as payment for the quarter ended 31 December 2011. The issue price is based on the 10-day volume weighted average price of MIT prior to 31 December 2011.

Following the issuance, the Manager holds 645,050 units in MIT and the total number of MIT units in issue is 1,628,822,170.

DBS Bank Ltd. and Goldman Sachs (Singapore) Pte. were the joint global coordinators for the initial public offering ("IPO") and listing of MIT. The issue managers for the IPO, were DBS Bank Ltd., Goldman Sachs (Singapore) Pte., Citigroup Global Markets Singapore Pte. Ltd. and Standard Chartered Securities (Singapore) Pte. Limited.

¹ Under the Trust Deed, the Manager is entitled to a base fee of 0.5% per annum of the value of MIT's Deposited Property or such higher percentage as may be approved by an Extraordinary Resolution of a meeting of Unitholders
