ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

Following the issuance of the new Units, the total number of MIT Units in issue has increased from 1,665,555,784 to 1,676,218,904.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 2QFY13/14 Distribution in cash today.
