ANNOUNCEMENT

ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 4QFY12/13 DISTRIBUTION PERIOD

2 May 2013 – Further to the announcement dated 23 April 2013 by Mapletree Industrial Trust Management Ltd., as manager (the “Manager”) of Mapletree Industrial Trust (“MIT”), in relation to the application of a distribution reinvestment plan (“DRP”) to the distribution of 2.37 Singapore cents per unit in MIT (“Unit”) for the Fourth Quarter Financial Year 2012/2013 from 1 January 2013 to 31 March 2013 (the “4QFY12/13 Distribution”), the Manager wishes to announce that the issue price of the new Units in MIT under the DRP is S\$1.5263 per Unit.

The issue price represents approximately 1% discount¹ to the adjusted volume-weighted average traded price² per Unit (“adjusted VWAP”) for all trades on Singapore Exchange Securities Trading Limited (the “SGX-ST”) for each of the Market Days during the period of 10 Market Days³ prior to and ending on the book closure date (“BCD”) on 2 May 2013.

The Notice of Election is expected to be despatched to all Eligible Unitholders⁴ on or around 8 May 2013. The Manager will announce further details about the despatch of DRP documents in due course.

¹ The issue price represents approximately a 2% discount to the volume-weighted average traded price per Unit for all trades on the SGX-ST during the period of 10 Market Days prior to and ending on the BCD.

² The adjusted VWAP is computed based on the volume weighted average traded price per Unit of all trades on the SGX-ST for each of the Market Days during the period of 10 Market Days prior to and ending on the BCD and subtracting the 4QFY12/13 Distribution for each of the Market Days prior to the first day of “ex-distribution” trading.

³ “Market Day” means a day on which the SGX-ST is open for trading in securities.

⁴ “Eligible Unitholders” means persons registered as unitholders of MIT in the Depository Register as at 5.00pm on the BCD of 2 May 2013 and with Singapore registered addresses.
