## ANNOUNCEMENT

## ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 2QFY14/15 DISTRIBUTION

*30 October 2014* - Further to the announcement dated 21 October 2014 by Mapletree Industrial Trust Management Ltd., as manager (the "Manager") of Mapletree Industrial Trust ("MIT"), in relation to the application of a distribution reinvestment plan ("DRP") to the distribution of 2.60 Singapore cents per unit in MIT ("Unit") for the Second Quarter Financial Year 2014/2015 from 1 July 2014 to 30 September 2014 (the "2QFY14/15 Distribution"), the Manager wishes to announce that the issue price of the new Units in MIT under the DRP is S\$1.3876 per Unit.

The issue price represents approximately 1% discount<sup>1</sup> to the adjusted volume-weighted average traded price<sup>2</sup> per Unit ("adjusted VWAP") for all trades on Singapore Exchange Securities Trading Limited (the "SGX-ST") for each of the Market Days<sup>3</sup> during the period of 10 Market Days prior to and ending on the book closure date ("BCD") on 30 October 2014.

The Notice of Election is expected to be despatched to all Eligible Unitholders<sup>4</sup> on or around 5 November 2014. The Manager will announce further details about the despatch of DRP documents in due course.

<sup>&</sup>lt;sup>2</sup> The adjusted VWAP is computed based on the volume weighted average traded price per Unit of all trades on the SGX-ST for each of the Market Days during the period of 10 Market Days prior to and ending on the BCD and subtracting the 2QFY14/15 Distribution for each of the Market Days prior to the first day of "exdistribution" trading.
