## ANNOUNCEMENT

### APPLICATION OF DISTRIBUTION REINVESTMENT PLAN FOR THE 3QFY15/16 DISTRIBUTION PERIOD ENDED 31 DECEMBER 2015

26 January 2016 – Mapletree Industrial Trust Management Ltd., as manager (the “**Manager**”) of Mapletree Industrial Trust (“**MIT**”), wishes to announce that the distribution reinvestment plan (“**DRP**”) will apply to the taxable income distribution of 2.82 Singapore cents per unit in MIT (“**Unit**”) in relation to the Third Quarter Financial Year 2015/2016 from 1 October 2015 to 31 December 2015 (“**3QFY15/16 Distribution**”). The **DRP** will be suspended after the 3QFY15/16 Distribution. Thereafter, Unitholders will receive their quarterly distributions in cash. The **Manager** may consider the re-application of the **DRP** at a later date and will notify Unitholders accordingly.

#### Application of the **DRP** for the 3QFY15/16 Distribution

The **DRP** provides unitholders of MIT (“**Unitholders**”) with the option to receive their distributions declared, either in the form of Units or cash or a combination of both.

The issue price of each new Unit under the **DRP** will be set at 1.0% discount to the adjusted volume-weighted average traded price<sup>1</sup> per unit (“**adjusted VWAP**”) for all trades on Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) for each of the Market Days during the period of 10 Market Days prior to and ending on the book closure date<sup>2</sup> (“**BCD**”).

Units under the **DRP** will be issued under the general Unit issue mandate obtained from Unitholders at the Annual General Meeting of MIT held on 15 July 2015.

**DRP** documents will be sent to Unitholders registered in the Depository Register<sup>3</sup> as at the **BCD** on Wednesday, 3 February 2016. Only Unitholders with Singapore registered addresses will be eligible to participate in the **DRP**.

<sup>1</sup> The adjusted **VWAP** is computed based on the volume weighted average traded price per Unit of all trades on the **SGX-ST** for each of the Market Days during the period of 10 Market Days prior to and ending on the **BCD** and subtracting the 3QFY15/16 Distribution for each of the Market Days prior to the first day of “ex-distribution” trading.

<sup>2</sup> “Book closure date” means the date to be determined by the **Manager** on which the register of Unitholders will be closed for the purpose of determining the entitlements of Unitholders to a distribution.

<sup>3</sup> “Depository Register” shall have the meaning ascribed to it in the Companies Act, Chapter 50 of Singapore.

Unitholders who wish to participate in the DRP and do not receive the DRP documents within three Market Days<sup>4</sup> after the expected date of despatch on Thursday, 11 February 2016 may obtain a copy from the Unit Registrar of MIT, Boardroom Corporate & Advisory Services Pte. The SGX-ST has granted MIT a waiver from Rule 862(5) of the Listing Manual of the SGX-ST (“**Listing Manual**”), which requires the payment date for distributions under the DRP to be made not less than 30 Market Days, but not more than 35 Market Days, after the BCD. MIT has obtained clearance from The Central Depository (Pte) Limited to allow the 3QFY15/16 Distribution to be made earlier than the minimum timeframe required under the Listing Manual so as not to unnecessarily delay the payment of distribution, which is in accordance to the timetable below.

The Manager will announce further details on the DRP for the 3QFY15/16 Distribution, including the issue price of new Units, in due course.
