| # Please specify details | <p>There was a series of transactions by subsidiaries of DBS Group Holdings Ltd ("DBSH") and Aetos Security Management Pte Ltd ("Aetos"). This has caused a change in the percentage level of the aggregate interest held by DBSH, Aetos and Mapletree Investments Pte Ltd. ("MIPL").</p> <p>DBSH is an associated company of Temasek Holdings (Private) Limited ("Temasek"). Aetos and MIPL are indirect subsidiaries of Temasek. Where DBSH, MIPL and Aetos have interest in the Units, Temasek is deemed to have an interest in those Units. Accordingly, there has been a change in the percentage level of Temasek's deemed interest to 994,734,800 Units (40.99%) comprising:</p> <p>i. 500,000 Units (0.02%) held by Aetos;</p> <p>ii. 10,801,552 Units (0.45%) in which DBSH has an interest; and</p> <p>iii. 983,433,248 Units (40.53%) in which MIPL has an interest.</p> <p>Temasek became aware of the change in the percentage level of its interest in the Units on 13 July 2012.</p> |
