However, Temasek is filing this notification form to report a change in deemed interest from 41.03% to 40.90% in the units of the Listed Issuer due to a change in the total number of units from 2,448,705,547 to 2,456,750,904 following the issuance of new units pursuant to the Listed Issuer's Distribution Reinvestment Plan ("DRP") on 2 June 2014. DBS Bank Ltd. ("DBS Bank") participated in the DRP and received 30,737 new units.

The filing of Temasek's deemed interest arises from the aggregation of interests held by Certis CISCO Security Pte. Ltd. ("Certis CISCO"), DBS Group Holdings Limited ("DBSH"), Mapletree Investments Pte Ltd ("MIPL") and Keppel Corporation Limited ("KCL").
