The new Units will rank pari passu in all respects with the existing Units.

Following the issuance of the new Units, the total number of MLT Units has increased from 2,478,389,073 to 2,483,660,849.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered mailing addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 2Q FY15/16 Distribution in cash on 27 November 2015.
