### **COMPLETION OF DIVESTMENT OF 531 BUKIT BATOK STREET 23**

Further to its press release dated 4 September 2018, Mapletree Logistics Trust Management Ltd., as Manager of Mapletree Logistics Trust (“MLT”), wishes to announce that the divestment of 531 Bukit Batok Street 23 in Singapore has been completed today.

Following this divestment, MLT’s portfolio stands at 138 properties, comprising 52 properties in Singapore, 9 in Hong Kong, 20 in Japan, 9 in Australia, 11 in South Korea, 20 in China (50.0% interest in 11 properties), 14 in Malaysia and 3 in Vietnam. The total value of assets under management is S\$7.6 billion<sup>1</sup>.
