ISSUE PRICE OF NEW UNITS TO BE ISSUED PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 4Q FY23/24 DISTRIBUTION

Further to the announcement dated 29 April 2024 by Mapletree Logistics Trust Management Ltd., as manager of Mapletree Logistics Trust ("MLT") (the "Manager") in relation to the application of the distribution reinvestment plan ("DRP") to MLT's distribution for the period from 1 January 2024 to 31 March 2024 (the "4Q FY23/24 Distribution"), the Manager wishes to announce that the issue price of the new units in MLT ("Units") to be issued under the DRP is S\$1.322 per Unit.

The issue price represents approximately 3.00% discount to the volume-weighted average traded price¹ per Unit ("**VWAP**") or 1.65% discount to the adjusted VWAP² for all trades on Singapore Exchange Securities Trading Limited (the "**SGX-ST**") during the period of 10 Market Days³ prior to and ending on the Record Date of **8 May 2024**.

The Notice of Election is expected to be despatched to all Eligible Unitholders⁴ on **15 May 2024** for which an announcement will be issued accordingly.

⁴ "Eligible Unitholders" means persons registered as unitholders of MLT in the Depository Register as at 5.00 p.m. on the Record Date of 8 May 2024 and with registered mailing address in Singapore.
