ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

3 December 2015 - Mapletree Industrial Trust Management Ltd., as manager (the "Manager") of Mapletree Industrial Trust ("MIT"), wishes to announce that it will issue 14,432,148 new units in MIT ("New Units") at an issue price of S\$1.4895 per Unit pursuant to MIT's distribution reinvestment plan ("DRP") in respect of MIT's distribution for the Second Quarter Financial Year 2015/2016 from 1 July 2015 to 30 September 2015 (the "2QFY15/16 Distribution") on 4 December 2015.

The New Units will be credited by 4 December 2015 to securities accounts of MIT unitholders ("Unitholders") who have elected to participate in the DRP. The New Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited ("SGX-ST") at 9.00 a.m. on 4 December 2015.

The new Units will rank pari passu in all respects with the existing Units.

Following the issuance of the New Units, the total number of MIT Units in issue has increased from 1,770,630,235 to 1,785,062,383.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 2QFY15/16 Distribution in cash on 4 December 2015.
