## **ANNOUNCEMENT**

### **ISSUANCE OF S\$125,000,000 3.58% FIXED RATE NOTES DUE 2029 UNDER THE S\$2,000,000,000 EURO MEDIUM TERM SECURITIES PROGRAMME**

18 March 2019 – Mapletree Industrial Trust Management Ltd., as manager (the “Manager”) of Mapletree Industrial Trust (“MIT”), wishes to announce that Mapletree Industrial Trust Treasury Company Pte. Ltd. (the “Issuer”), a wholly-owned subsidiary of DBS Trustee Limited (in its capacity as trustee of MIT, the “Trustee”), has today executed a pricing supplement to issue S\$125,000,000 in principal amount of 3.58% fixed rate notes due 2029 (the “Notes”).

#### **Principal Terms of the Notes**

The Notes were issued under the S\$2,000,000,000 Euro Medium Term Securities Programme, which was established on 5 September 2018. The payment obligations of the Issuer under the Notes will be unconditionally and irrevocably guaranteed by the Trustee.

The principal terms of the Notes are as follows:

Issue Size	:	S\$125,000,000
Issue Price	:	100% of the principal amount of the Notes
Interest	:	3.58% per annum
Issue Date	:	26 March 2019
Maturity Date	:	26 March 2029

The proceeds arising from the issuance of the Notes will be used towards refinancing the existing borrowings.

The Notes are expected to be assigned a rating of ‘BBB+’<sup>1</sup> by Fitch Ratings, the same rating as MIT’s long-term Issuer Default Rating.

### **Disclosure pursuant to Rule 704(31)**

Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited (the “SGX-ST”), the Notes contain certain conditions similar to those in some of MIT’s loan facilities and notes issued under the S\$1,000,000,000 Multicurrency Medium Term Note Programme (collectively, the “Debt Facilities”).

In the event of the following:

- a. The Manager resigns or is removed as a manager of MIT and the replacement manager is not appointed in accordance with the provisions of the trust deed constituting MIT; and/or
- b. The Manager and/or the replacement manager ceases to be a direct or indirect wholly-owned subsidiary or subsidiary of Mapletree Investments Pte Ltd, the sponsor of MIT.

(collectively, the “Conditions”), the lender(s) may cancel the available commitment under the loan facilities and holders of outstanding notes may direct that the notes become immediately due and payable, whereupon the Trustee shall pay an amount equal to the aggregate of the principal amounts outstanding, all interest accrued thereon and all other amounts accrued or outstanding within a stipulated period.

The aggregate amount of Debt Facilities that may be affected by a breach of the Conditions is S\$1,887.9 million. As at the date of this announcement, there has been no breach of the Conditions.

An application has been made to the SGX-ST for the listing and quotation of the Notes on the SGX-ST. The SGX-ST assumes no responsibility for the correctness of any of the statements made or opinions expressed or reports contained herein. Admission to the Official List of the SGX-ST and quotation of the Notes on the SGX-ST is not to be taken as an indication of the merits of the Issuer, MIT, the Manager, the MIT Trustee, their respective subsidiaries (if any), their respective associated companies (if any), the Programme or the Notes.

The Notes are expected to be listed on the SGX-ST on or about 26 March 2019.
