

ANNOUNCEMENT

DISCLOSURE PURSUANT TO RULE 704(31) OF THE LISTING MANUAL OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED

31 May 2022 – Mapletree Industrial Trust Management Ltd., as manager (the “Manager”) of Mapletree Industrial Trust (“MIT”), wishes to announce that wholly-owned subsidiaries of MIT (the “Borrowers”) have entered into new loan facility agreements today, which are guaranteed by DBS Trustee Limited as trustee of MIT (the “Trustee”) (each of the Borrowers and the Trustee being an “Obligor”).

For the purpose of disclosure under Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited (“SGX-ST”), the new loan facility agreements contain certain conditions similar to those in some of MIT’s loan facilities and notes issued¹ (collectively, the “Debt Facilities”).

In the event of the following:

- a. The Manager resigns or is removed as a manager of MIT and the replacement manager is not appointed in accordance with the provisions of the trust deed constituting MIT; and/or
- b. The Manager and/or the replacement manager ceases to be a direct or indirect wholly-owned subsidiary or subsidiary of Mapletree Investments Pte Ltd, the sponsor of MIT.

(collectively, the “Conditions”), the lender(s) may cancel the available commitment under the loan facilities and holders of outstanding notes may direct that the notes become immediately due and payable, whereupon the relevant Obligor shall pay an amount equal to the aggregate of the principal amounts outstanding, all interest accrued thereon and all other amounts accrued or outstanding within a stipulated period.

¹ Notes issued under the S\$1,000,000,000 Multicurrency Medium Term Note Programme and S\$2,000,000,000 Euro Medium Term Securities Programme.

The aggregate amount of Debt Facilities that may be affected by a breach of the Conditions is S\$4,092.3 million.

As at the date of this announcement, there has been no breach of the Conditions.
