PAYMENT OF MANAGER'S BASE FEE BY WAY OF ISSUE OF UNITS IN MAPLETREE INDUSTRIAL TRUST

6 February 2023 - Mapletree Industrial Trust Management Ltd., as manager (the "Manager") of Mapletree Industrial Trust ("MIT"), wishes to announce that 596,772 new units in MIT ("New Units") have been issued to the Manager today at S\$2.2110 per unit. The issue price is based on the 10-day volume-weighted average traded price of MIT prior to and ended on 31 December 2022.

The issuance of the abovementioned New Units was for the payment of the base fee in relation to the management of the following properties of MIT for the quarter ended 31 December 2022, unless otherwise stated:

- 1. 25% of base fee in relation to 8011 Villa Park Drive, Richmond, Virginia, which was acquired on 12 March 2021¹; and
- 50% of base fee in relation to 29 data centres in the United States of America, which were acquired on 22 July 2021².

Following the issuance, the Manager holds 24,933,673 units in MIT and the total number of MIT units in issue is 2,724,260,022.
