## RECEIPT OF APPROVAL IN-PRINCIPLE FOR LISTING AND QUOTATION OF 92,593,000 NEW UNITS IN MAPLETREE INDUSTRIAL TRUST PURSUANT TO THE PRIVATE PLACEMENT

Capitalised terms used herein, but not otherwise defined, shall have the meanings ascribed to them in the announcement of Mapletree Industrial Trust dated 25 May 2023 titled "Launch of Equity Fund Raising By Way of a Private Placement to Raise Gross Proceeds of No Less Than Approximately \$\$200.0 Million".

Further to its announcements dated 25 May 2023 and 26 May 2023, Mapletree Industrial Trust Management Ltd., in its capacity as manager of Mapletree Industrial Trust ("MIT", and as the manager of MIT, the "Manager"), wishes to announce that approval in-principle has been obtained today from Singapore Exchange Securities Trading Limited (the "SGX-ST") for the listing and quotation on the Main Board of the SGX-ST of 92,593,000 New Units which are proposed to be issued pursuant to the Private Placement. The SGX-ST's in-principle approval is subject to conditions set out below.

The SGX-ST's in-principle approval is not to be taken as an indication of the merits of the Private Placement, the New Units, MIT and/or its subsidiaries. The SGX-ST assumes no responsibility for the accuracy of any of the statements made, reports contained and opinions expressed in this announcement.

The SGX-ST's in-principle approval is subject to the following:

- (i) compliance with the SGX-ST's listing requirements;
- (ii) a written undertaking from the Manager that it will comply with Rule 704(30) and Rule 1207(20) of the Listing Manual of the SGX-ST (the "Listing Manual") in relation to the use of the proceeds from the Private Placement and where proceeds are to be used for working capital purposes, the Manager will disclose a breakdown with specific details on the use of proceeds for working capital in its announcements on use of proceeds and in the annual report;
- (iii) a written undertaking from the Manager that it will comply with Rule 803 of the Listing Manual;
- (iv) a written undertaking from the Joint Global Co-ordinators and Bookrunners that they will ensure that the Manager will comply with Rule 803 of the Listing Manual;
- (v) a written confirmation from the Manager that it will not issue the New Units to persons prohibited under Rule 812(1) of the Listing Manual; and
- (vi) a written confirmation from the Joint Global Co-ordinators and Bookrunners that the New Units will not be placed out to persons under Rule 812(1) of the Listing Manual.

As announced on 26 May 2023, DBS Bank Ltd.'s Multi-assets Investments Unit ("**DBS MI**") has been allocated 4,860,000 New Units under the Private Placement. Mapletree Investments Pte Ltd (the

"Sponsor") is a substantial unitholder of MIT. The Sponsor is in turn indirectly owned by Temasek Holdings (Private) Limited ("Temasek") through Temasek's wholly-owned subsidiary, Fullerton Management Pte Ltd. Accordingly, Temasek, through its indirect interest in the Sponsor, is deemed a substantial unitholder of MIT. DBS Bank Ltd. ("DBS") is a wholly-owned subsidiary of DBS Group Holdings Ltd ("DBSH") and based on the latest annual report of DBSH for the financial year ended 31 December 2022, Temasek had a direct and deemed interest of 29.14% in DBSH as at 10 February 2023.

In response to an application by DBS, which is one of the Joint Global Co-ordinators and Bookrunners, the SGX-ST has stated that it has no objection to MIT's placement of New Units to DBS MI pursuant to Rule 812(4) of the Listing Manual of the SGX-ST, subject to the conditions disclosed in the Manager's announcement dated 26 May 2023.
