## PROPOSED DIVESTMENT OF 30 TUAS SOUTH AVENUE 8

**Singapore**, **10 May 2024** – Mapletree Logistics Trust Management Ltd., as manager (the "Manager") of Mapletree Logistics Trust ("MLT" or the "Trust"), would like to announce that HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of MLT) has entered into a Purchase Agreement with an unrelated third party buyer for the proposed divestment of 30 Tuas South Avenue 8 in Singapore ("the Property") at a sale price of S\$10.5 million. JTC Corporation has granted inprinciple approval for the transaction subject to the parties complying with the stipulated conditions.

The proposed divestment is in line with the Manager's continued efforts to rejuvenate its portfolio through selective divestments. Capital released from the divestment will provide MLT with greater financial flexibility to pursue investment opportunities in high specification, modern logistics facilities with higher growth potential.

The Property is a part single-storey, part two-storey warehouse with a building age of over 25 years and a net lettable area of approximately 5,233 square metres. The sale price of S\$10.5 million is 10.5% above the latest valuation of S\$9.5 million as at 31 March 2024.

The proposed divestment is expected to be completed by 1Q FY24/25. It is not expected to have a material impact on MLT's net asset value and net property income for FY24/25. Following the divestment, MLT's portfolio will consist of 187 properties<sup>1</sup>.
